Ligonier Township Supervisors Regular Meeting Minutes

January 6, 2020

The Ligonier Township Supervisors met in regular session at 5:00 PM. Secretary/Treasurer Stephanie Verna took roll call. Present were Chair, John Beaufort; Vice Chair, Paul Knupp; Secretary/Treasurer, Stephanie Verna; Supervisor, Dan Weimer; and Supervisor, D. Scott Matson.

Public Comment

- 1. Ed Oles, Environmental Subcommittee Last year the Township expressed concern about the sewage infrastructure expenses. Urged the Board to consider updating the drilling ordinance.
- 2. Kerri Goldinger Ligonier Beach in favor of restoring the historic landmark. It's been here 90+ years and will bring in more revenue and recreation. Drove from Butler to use the pool every weekend when they did not live here. People have grown up with the pool and have fond memories. There are plenty of other walking trails and a skate park in Greensburg.
- 3. Matt Goldinger has lived here six years. There is 90 years of history. To use a pool, one needs to go to Latrobe or Derry. Doesn't know what the plan is, but heard rumors it could be a pool or could be green space, hiking trails. There are plenty of walking areas. There is already a lot of green space. Has there been a feasibility study?
- 4. Annie MacDougall reiterated what Ed Oles said spent years putting together best practices, when will this ordinance get revisited?
- 5. Keith Lisk Ligonier Beach is a cool pool and it has had some issues but would love to see it revitalized. The summer weather has changed could it be used year round? Skating rink? Volleyball court? Mini-boardwalk with concession stands? There may be local opportunities for other businesses. Also, spoke to the Army Corp of Engineers regarding to help with the flooding. There is a program where they may be able to rectify the problem, which starts with a Letter of Intent. We need to get to the root of the problem so we do not waste money.
- A motion was made by Stephanie Verna and seconded by Paul Knupp to approve the December 10, 2019 regular meeting minutes with two corrections to motions made regarding the subdivision plans. (Add that Stephanie Verna was the second.) Motion carried.

Supervisors Comment

Supervisor Knupp – welcomed Dan Weimer.

Supervisor Verna – encouraged people to stay informed by participating in the Beach Park meetings and come with an open mind.

Supervisor Beaufort – addressed the drilling concerns and reminded audience the ordinance update was postponed until a new engineer was selected (which happened today at the re-org meeting).

The Township received a \$10K grant from RK Mellon Family Foundation for the Mill Creek Memorial Park fishing platform.

Snow plow drivers – casual/seasonal. Recommend a fair rate of \$20/hr.

- A motion was made by Paul Knupp and seconded by Dan Weimer to set the temporary drivers at \$20/hour. Motion carried.
- A motion was made by Paul Knupp and seconded by Dan Weimer to set 'Dumpster Days' for April 18th, 8:00 AM to noon. Motion carried.

Supervisors Comments

Supervisor Knupp thanked Glenn Kalp for his service on the LTMA Board. Also thanked Wes Binkey for his 32 years.

Supervisor Verna encouraged people to participate in the Ligonier Beach Park planning process.

Supervisor Matson stated he is tired of the illegal dumping at the recycling bins. Discussion about the future or recycling.

Resident Dan Keisel raised a concern that if we get rid of recycling the illegal dumping elsewhere will get worse.

Supervisor Verna said it is not an effective program – not cost effective and is a distraction. This is to be intended for paper and cardboard – this has been brought up multiple times.

Supervisor Beaufort echoed concerns that recycling is nice to have but it's a mess, especially around the holidays- there were four dumpsters overflowing. Solicitor Korns suggested adding this topic next month's agenda.
