A motion was made by Komar and seconded by Binkey to accept all low bids with the following exceptions. (1) Derry Stone AS2 does not meet PADOT specifications for use as intended and (2) asphalt will be awarded to Hanson due to a savings in transportation costs, which creates a net savings in gross cost per ton. It is also to be noted that sufficient quantities of all materials were added to the quantities bid to include work to be done for Ligonier Borough.

A motion was made by Komar and seconded by Binkey to approve a site plan for Jason McKlveen on State Route 711 in Oak Grove to operate a seasonal business selling landscaping materials. Hours are by

appointment daily from 7 am to 9 pm. Approval is subject to applicant acquiring a Driveway Permit from PA DOT prior to 15 July. Temporarily permission has been granted by the Horrell Neiderhiser business to use their access driveway. There will be no lighting of the property and a sign permit will be applied for. Motion carried.

A motion was made by Komar and seconded by Binkey to hire Michael Bendorf to the Road Crew effective after drug testing and physical examinations are completed satisfactorally. Motion carried.

There being no further business brought before the Board, a motion was made by Binkey and seconded by Whipkey to adjourn the meeting at 8:38 am. Motion carried.
