Separate sealed bids for the construction of the Harvey Road Bridge Preservation Project, Contract No. 2025-BR-01, will be received by the Township of Ligonier (Owner) at their office located at One Municipal Park Drive, Ligonier, PA 15658 **until 3:00 P.M., local time, on Tuesday, December 9, 2025. Bids will be opened and read aloud at the regular public meeting at 7:00 P.M. December 9, 2025.**

The Issuing Office for the Bidding Documents is: The EADS Group, Inc. (Engineer), 450 Aberdeen Drive, Somerset, Pennsylvania 15501. Telephone No. (814) 445-6551. Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 8:00 A.M. and 4:30 P.M. and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Bidding Documents may be obtained from The EADS Group, Inc., [during the hours indicated above], upon payment of a non-refundable fee of **\$100.00** for printed format or **\$25.00** for electronic format, both of which includes 6% Pennsylvania sales tax. Checks for Bidding Documents shall be payable to "The EADS Group, Inc." To access the electronic format, the bidder must have a valid e-mail address and will require internet connection. Bidders must purchase Bidding Documents (in either format) from The EADS Group, Inc. to be eligible to bid this project.

Contract No. 2025-BR-01 Harvey Road Bridge Preservation Project consists of beam cleaning and painting, deck replacement, and stone masonry mortar joint pointing. The Project is located in the Township of Ligonier, Westmoreland County, Pennsylvania.

Prior to the award of the contract, the successful bidder shall furnish a satisfactory Performance Bond and a Labor and Material Payment Bond to the Owner, in the form contained in the Contract Documents and executed by a satisfactory circular 570 listed surety, each equal to 100% of the total contract amount. The bidder will also furnish evidence of insurance coverage as required by the contract documents.

This project is funded in whole or part with federal funds administered by the Westmoreland County Planning and Community Development CDBG Program. The obligations imposed on the Owner by the financing agency shall apply to and be acceptable to the successful bidder. Davis-Bacon wage rates and other federal requirements apply and are included in the bid documents. Labor Compliance is mandatory.

Notice is also hereby given that this project is regulated under Executive Order 11246 - Equal Employment Opportunity and related contract specifications apply or any updates that the current administration puts into place through the timeframe of the project.

Contractors should give the best effort to solicit proposals from Minority, Women and Section 3 Business Enterprises for potential subcontractors.

Notice is hereby given that all bidders must comply with Westmoreland County's Section 3 Plan included in the bid documents when related. Section 3 is a provision of the Housing and Urban Development Act of 1968 (12 U.S.C. 1701u) that is regulated by the provisions of 24 CFR 75.
