The regular meeting of the Ligonier Township Supervisors was held Tuesday, May 14, 2024 at 7:00 p.m. in the Municipal Building with Chairman Dan Resenic presiding.

Members Present: Dan Resenic, Erik Ross, Stephanie Verna, and John Beaufort. Scott Matson was absent.

Others Present: Township Manager Michael Strelic, Solicitor Dan Hudock, Chief of Police Michael Matrunics, and Finance Officer Bethany Caldwell.

COMMENTS FROM THE PUBLIC

1. Terrell Funk – presented the Rec Board's list of recommended action items for a Ligonier Beach cleanup.

2. Lewis Thomas – asked about property maintenance ordinance enforcement.

3. Gregory Smith – spoke about the problems of lawn clippings on the road and reminded all it is illegal and punishable by fine.

MANAGER

Mr. Strelic reported a tornado touched down last week in the Austraw Raod – McCurdy Trail area. Thankfully, it touched down in a mostly wooded area and only two houses were hit and no one was seriously injured. However, there was a lot of clean up for the Public Works crew. Mr. Strelic has moved some reserve funds to the Township's Pennsylvania Local Government Investment Trust (PLGIT) account - \$200k was invested in the term account earning 5.42% interest for a 6 month term. The plan is to diversify funds keeping some with Janney and some with PLGIT.

SOLICITOR

Mr. Hudock had nothing to report.

POLICE

Chief Matrunics reiterated the importance of keeping grass clippings and yard waste off the roads. He advised residents not to get into confrontations with their neighbors but call the police instead.

TREASURER

Supervisor Verna updated the rest of the Board on the finance committee's first quarter meeting, the numbers are trending with planned budget.
