# **MANAGER**

Mr. Strelic reported the Country Market is in compliance with both the maximum number of vendors and vendor spaces. The LVPD and market staff continue to work together making it a safer event; Chief Matrunics said the pedestrian walkway was moved to allow for a better traffic flow. Mr. Strelic also reported that despite recent grant related improvements made to Claycomb Road, the road is unfortunately not holding up. Staff are actively researching why the

work is deteriorating and have consulted the Township's engineer as well as Conservation District staff. Samples will be taken next week and sent out for testing.

Mr. Hudock reported he is working with staff on a few code complaints and will be filing them with the local magistrate.

# **POLICE**

# Ligonier Beach Master Site Development Plan & Pool Feasibility Study:

Janelle Emory reported the FOLB reviewed the proposals and selected Mackin as the consultant to complete the study.

**A motion** was made by Erik Ross and seconded by Stephanie Verna to select Mackin as the consultant to complete the Ligonier Beach Master Site Development Plan & Pool Feasibility Study. Motion carried unanimously.

# **Ligonier Beach:**

There was a brief discussion about addressing a potential safety issue before allowing a volunteer community cleanup event to be scheduled on the property.

**A motion** was made by Stephanie Verna and seconded by John Beaufort directing Public Works to place orange fencing (around the former footprint of the filter and pump houses), properly post the area with "No Trespassing" signs, and monitor the property, ensuring the fencing and signage are in place. Motion carried 4:1 with Supervisor Matson voting nay.

## Resolution 2024-R-08, Transfer to General Fund Reserves:

**A motion** was made by Erik Ross and seconded by John Beaufort to transfer \$200,000 out of the General Fund and into the PLGIT account. Motion carried unanimously.

# **Resolution 2024-R-09, Fund Policy Amendment:**

**A motion** was made by Erik Ross and seconded by Scott Matson to approve 2024-R-09, amending the Township's Fund Policy. Motion carried unanimously.

# Ordinance 2024-O-05, No Parking Zone Old Lincoln Highway West

**A motion** was made by Stephanie Veran and seconded by Erik Ross authorizing Mr. Strelic to advertise the possible adoption of ordinance 2024-O-05. Motion carried unanimously.

## **EXECUTIVE SESSION**

The Supervisors went into executive session at 7:35 p.m. to discuss the union's healthcare grievance and resumed their regular meeting at 7:45 p.m.

# **Healthcare Grievance:**

**A motion** was made by Erik Ross and seconded by John Beaufort directing Mr. Strelic to hire a third party to administer payment of the healthcare cost differences incurred by the union employees so that HIPPA regulations are not violated. Motion carried unanimously.

#### ADDITIONAL COMMENTS FROM THE PUBLIC

Janell Emery – suggested donation boxes be set up at the Ligonier Valley trail heads similar to other community trails.

#### ADDITIONAL COMMENTS FROM THE SUPERVISORS

Supervisor Beaufort – Announced that the four Ligonier Valley fire companies are addressing donation request letters this week, this is their major fundraiser. The bluegrass festival is coming up at the end of the month. With respect to Mr. Gongaware's letter, he agrees we have to live with the final ruling and that something did happen. He thinks an apology is a good idea and it's too bad it didn't happen sooner, but it would still be good to offer an apology.

Supervisor Verna – Commented on the Country Market event and was pleased to see improvements being made. She noted it is an important asset to the community. As one of the founding members of the Regional Police Commission, she explained the spirit and intent of forming a regional department was to better serve the community and provide more career opportunities for the officers. She said the more she learns what all the officers have to do, the more she is aware of how fortunate we are, to have dedicated officers. It is unfortunate there is some animosity between some members on the board and our police department. To move forward, we all have to work together, but she would like to have it addressed, formally as a board. Our motivation is to serve the community as a whole and to lift up the organizations that also serve.

Supervisor Matson – Said he watched the incident video five times and saw nothing. He noted that some people in the community think Mr. Ross should apologize and some people think Officer Hakel should apologize. Everybody has their own opinion, it's a free country.

Supervisor Ross – No comment.

Supervisor Resenic – Said the incident between Officer Hakel and Supervisor Ross was unfortunate and he deferred to Judge McCormick's ruling. He thinks the best way to move forward is to have Mr. Ross and Officer Hakel get together with a neutral individual to discuss and shake hands. He doesn't think asking either one to apologize is going to heal anything; they are grown adults and a handshake will do a lot more good.

## **MOTION TO ADJOURN**

**A motion** was made by Erik Ross and seconded by Scott Matson to adjourn the meeting. All of the Board was in favor. The meeting was adjourned at 7:54 p.m.
