Ligonier Township Supervisors Regular Meeting Minutes

September 26, 2023

The Supervisors of Ligonier Township met in regular session at 4:30 p.m. Present were Chair, Dan Resenic; Vice Chair, Erik Ross; Secretary/Treasurer, Stephanie Verna; Supervisor, D. Scott Matson; and Supervisor, John Beaufort.

Also present were Manager, Michael Strelic; Solicitor, Dan Hudock; Engineer, Ben Faas; Zoning / Code Enforcement Officer, Rick Krouse; and Finance Officer, Bethany Caldwell.

Comments from the Public

1. Debbie Messer – Filed two Right-to-Know requests.

Comments from the Supervisors

There were no comments from the Supervisors.

 A motion was made by Stephanie Verna and seconded by Scott Matson to approve the minutes from the September 12, 2023 meeting. Motion carried.

Manager Report

Mr. Strelic reported the crew was cleaning up the roads that were chip-sealed, but the hydraulics on the sweeper went out. He is working on the 2024 budget and 5-year plan. He asked the Board Members to send him their emergency contact information.

Engineer Report

Mr. Faas deferred to the later in the meeting (Unfinished Business).

Solicitor Report

Mr. Hudock reported he's been working with Mr. Krouse and will be filing the Sleasman complaint this week. He requested an executive session to discuss the DEP's Act 537 appeal litigation.

Staff Reports

1. Zoning / Code Enforcement – Mr. Krouse provided his August report and gave an update on the Zoning Hearing Board (ZHB) meeting.

Supervisor Resenic asked about a compliant on Owl Hollow Road and Mr. Krouse explained he has been working on the complaint, but noted that the property is agricultural and is therefore protected by multiple state laws that protect farming and farm equipment.

- 2. Finance the August Budget vs. Actual report will be presented next month.
 - A motion was made by Stephanie Verna and seconded by Erik Ross to approve the bills as presented. Motion carried.

Old Business

- Resolution 2023-R-22, LSA grant submittal on behalf of Southern Alleghenies Museum of Art (SAMA). SAMA got clarification on the grant program process -SAMA will pay vendors directly. The Township is the "pass through" for reimbursement. SAMA has already written the grant and all the Township has to do copy and paste the text into the grant's portal.
 - A motion was made by Dan Resenic and seconded by Erik Ross to approve 2023-R-22. Motion carried.
- 2. Westmoreland County stormwater grant the agreement was received Friday. No action is required at this time, as staff need to reach out to the county for clarification on scope of work.
 - A motion was made by Erik Ross and seconded by Scott Matson to appoint Josh Byers to the Zoning Hearing Board with a term expiring 12/31/27. Motion carried.
 - A motion was made by Scott Matson and seconded by Stephanie Verna to approve Wessel & Company as the Township's auditor. Motion carried.
- 3. Ordinance 2023-O-06 Fire Department Recognition Ordinance was tabled to allow the Board and Mr. Hudock more time to review the ordinance's language.
- 4. Residential & commercial sewage line inspection testing This would need an ordinance, rules & regulations, and designate the Municipal Authority to carry out the testing process and enforcement. Testing is usually triggered by an event (sale or refinance). The Board is taking steps to ensure the best prices for our residents we are in negotiations with MAWC and they've commented that they treat more sewage after a rain event. Supervisor Resenic is in favor if pressure testing as it is a more reliable method and harder to dispute its accuracy.
 - A motion was made by John Beaufort and seconded by Scott Matson to direct the solicitor to draft a comprehensive Infiltration & Inflow inspection testing at transfer ordinance while working with the township engineer and LTMA. Motion carried.

New Business

Special Events Permit – After reviewing the Special Events Ordinance, Mr. Strelic noted that the Township cannot revoke a special event permit, it can only issue a fine. The ordinance should be revised. Supervisor Verna noted there is an additional issue that needs to be addressed - the Country Market is out of compliance with their permit. She asked if they were notified. Mr. Strelic explained there have been discussions and they disagree and think they are compliant – they have more vendors but the same number of "spots." Supervisor Verna asked that the County Market be notified so they can plan accordingly.

Comments from the Public

There were no comments from the public.

Comments from the Supervisors

Supervisor Matson – Said he rides around the Township in the evenings and is seeing some improvements, notably Serena, Claycomb, and Jacob Miller Roads. He would like to see the Fire Departments get \$15k each in next year's budget.

Supervisor Ross – No comment

Supervisor Verna – Noted there is a lot of gravel at the intersection of Brallier Road and Route 30 and it's hazardous. There might not be much the Township can do to alleviate the cause, but is concerned as it is unsafe.

Supervisor Beaufort – No comment

Supervisor Resenic – Commended the Public Works Department, he has seen a lot of good activity lately and is pleased to have a working foreman out with the Crew.

Executive Session

The Supervisors went into executive session at 5:00 p.m. to discuss the DEP's Act 537 appeal litigation and resumed regular meeting at 5:35 p.m.

 A motion was made by Erik Ross and seconded by Stephanie Verna to adjourn the meeting at 5:36 p.m. Motion carried.
