# **APPROVAL OF THE MINUTES**

Dan Weimer made a motion to accept the May 22, 2025 meeting minutes, seconded by Chris Hefner. Motion carried unanimously.

## **COMMENTS FROM THE PUBLIC**

Thomas A. Becer: Spoke in opposition of the solar project due to concern about glare, noise and deceased property values.

Jan Milburn: Had information regarding solar developments that she wanted to present to the commission and expressed the need to ensure all standards and regulation were followed if approval is given.

## **MDF Consolidation Plan**

Zoning Officer Krouse explained the plan, it is the consolidation of four existing lots into one lot. No non-conformities are being created, the resulting lot is in-line with the townships ordinances and the townships SEO has reviewed and given approval.

**A motion** was made by Mike McCaplin and seconded by Chris Hefner to recommend the MDF Consolidation Plan to Supervisors. Motion carried unanimously.

## Conditional Use: Becer property Principal Solar Energy System

Township Solicitor Hudock explained the conditional use consideration and process.

Bill French from Sunvest LLC conducted a presentation on the generalities of the project, some background on Sunvest LLC and the general process of producing solar energy.

Zoning Officer Krouse explained the timeline of process of considering the authorization of a conditional use.

Township Engineer Ben Faas gave some general comments on the conditional use application.

Various Commissioner had questions on subjects ranging from financial consideration, project company structure, benefit to the township and impact on electric prices.

**A motion** was made by Mike McCaplin and seconded by Chris Hefner to recommend approval to Supervisors. Motion carried by the following vote Chris Hefner, Mike McCaplin and Dan Weimer voted yes; Martin Knizer voted no and Barb Nalle abstained.

Zoning Officer Krouse commented on the purpose and content of the letter.

**A motion** was made by Chris Hefner and seconded by Mike McCaplin to approve the letter of support. Motion carried unanimously.
